The receivables under the Borealis Loans and the Current Account were each contributed at nominal value in Rosier SA's capital, for an aggregate amount of EUR 50,000,000 and against the issuance of 2,750,000 new ordinary shares. 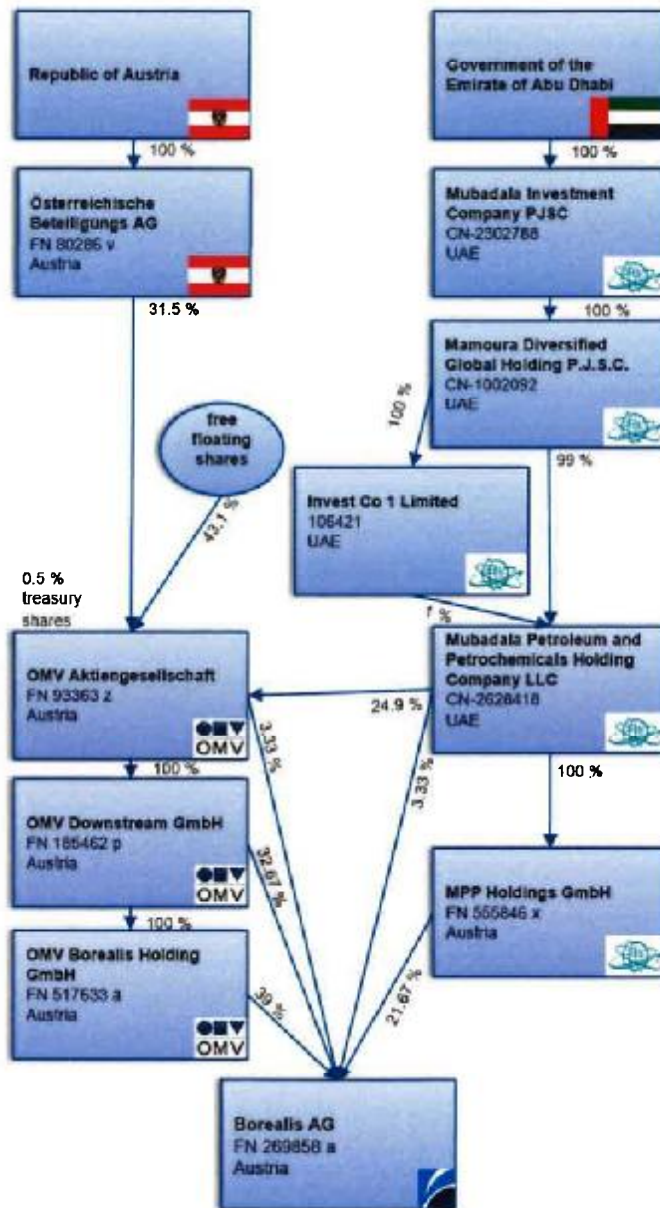
